

**NLAPW 2008 Biennial Juried Art Competition and Exhibition Entry Form**  
**Exhibit to be held April 25-27, 2008 at the Westin Alexandria Hotel, Alexandria, Virginia**

**This contest is open to all active Pen Women.** You may submit **up to three entries.** All work must be original, completed in the last three years, and not previously submitted to the NLAPW Biennial Exhibit.

**Entry Fee:** Each application must be accompanied by a **non-refundable** entry fee of **\$35.00** for three entries from which one will be selected. Make check or money order payable to **NLAPW Biennial Art.**

**Deadline:** postmarked by **January 31, 2008**

**Awards:** Best in Show, Awards of Excellence and Merit, Honorable Mention, and others

**Categories:** Works in two- or three-dimension including Oil, Acrylic, Watercolor, Pastel, Graphics, Mixed Media, Sculpture, and Photography.

**Limitations:** Works of art may not exceed 15"x 15" in either direction, including frame. They may be smaller, for example 6"x 6", 8" x 10", 11"x 14", etc. **No glass.** Plexiglas only and ready to hang. Sculptures may not exceed 15"x 15" and must not weigh more than 50 pounds.

**Submission Instructions: Slides:** Two identical 35 mm 2"x2" cardboard mounted in plastic sleeves. The front of the slide must include artist's name, title of work, and outside dimensions of artwork, arrow pointing up.

**Digital Format:** Two- and three-dimensional work shall be supplied digitally in **JPEG** file format. Three-dimensional work shall have photos of front, side, and back. The CD must include artist's name, title of artwork, and medium. Please number each digital disk to correspond with your entry form. Insurance is the responsibility of the artist. Twenty percent of every sale will be donated to NLAPW.

**Jurors:** DAWN LEE (has an MFA from Long Island University and is the director of the Omni Gallery, Uniondale, New York) and ROSALIE O'DONNELL (director of the Torpedo Factory, The Art League, Alexandria, Virginia).

**NOTE:** Shipping instructions will be sent with acceptance notices. Return shipping will be paid by BEAF, a League account funded by donations and accrued interest. Include a #10 (business-size) **SASE** for return of submitted CDs and slides. Insurance is the responsibility of the artist.. 20% of every sale is donated to NLAPW.
